

_____, do hereby give permission for him/her to participate in the Colonel By Band trip to Cuba. My son/daughter and I understand that he/she assumes full responsibility for his/her own actions and shares responsibility for the group's actions. In case of an emergency, I legally authorize the trip chaperones to authorize any medical services that my child might require. I have listed on the student information sheet the prescription drugs that my child will have with him/her on the trip, and any allergies.

My son/daughter and I further understand that he/she must abide by all rules and regulations set by the school board, school, trip chaperones, parks, hotels, airlines, bus companies, restaurants, etc. If any of these rules (partial listing below) are broken, the participant may be sent home at his/her own expense without refund. If this happens, (participant being sent home), the parent or legal guardian will be advised and the chaperones will arrange for transportation home.

Following are some of the rules and regulations for this trip that all participants must abide by at all times:

1. **Alcohol and Drugs:** It is illegal for a participant to be found in the possession of or under the influence of alcohol and/or drugs. A participant found under the influence or in possession of alcohol and/or drugs will be immediately expelled from the trip without refund. Notification regarding prescription drugs must be listed on the back of this sheet and presented to the head chaperone before departure.
2. **Unacceptable Conduct:** It is expected that students will not partake in any excessive rowdiness, fighting, damaging of property, unsafe or endangering action, illegal act(s) including stealing or shoplifting, and shall follow staff and/or chaperone rules at all times. Participants shall act in a socially acceptable and culturally respectful manner at all times. As well, he/she must participate totally and willingly in all activities on the trip itinerary.
3. **Stowaways:** Any paid participant inviting or encouraging a non-paying person (or stowaway) to participate on the trip, stay in a hotel room, or enter any attraction with the group, will lose his/her privilege of participation.
4. **Behaviour this year:** In addition, if a participant is found in possession of or under the influence of alcohol and/or drugs, or is engaging in unacceptable conduct on or at any other school event prior to the trip, he/she will be removed from the trip and will not be refunded money if it is beyond the refund date.
